City staff: I want to continue updating you on what little I do know about the investigation that began last May with the search warrants served at the residences of our Council Members (the ones in office at that time) and others. Subpoenas were delivered to the Clerk's Office today for documents related to the items listed below (most of which, the Clerk indicates, have already been provided to them). In addition, I was served with a subpoena to appear before a grand jury next Wednesday, as was Tom DeSantis. Our testimony is being requested just as witnesses.

Also, some in the media have tried to make an issue of an item on tonight's Council agenda; it is a routine update by the City Clerk of the City's record retention policy. This is done every few years to keep current with technological advancements and to comply with State law. Other cities do this as a routine update as well. Prior year updates were approved by the Council in 2003 and again in 2007. An outside consultant has been working on this update for over one year, obviously well before any investigation began. Tonight's item is on the consent calendar, as was the previous update. The City Clerk will be pulling this item from the agenda and preparing a comprehensive report to present to the City Council at a later date when the consultant can attend and provide information regarding this routine update. I don't know if the record retention update prompted today's influx of subpoenas, but as always the Clerk's Office and City staff will comply fully in providing copies of these items.

Dear Ms. Steel:

Thank you for your letter dated March 11, 2013 regarding the City of Moreno Valley's unencumbered Low-and-Moderate Income Housing Funds dated March 11, 2013. You may be pleased to know that on March 14, 2013, the City received a letter from the Department of Finance (DOF) rescinding the prior demand for the Successor Agency to return Low-Mod Income Housing Funds (LMIHF) to the State. Hi Michelle -

Henry asked for a bullet point outline of today's meeting. These are the salient points as I saw them. Please feel free to share this with others as you deem appropriate.

- The Nason property, consisting of two parcels totaling 59.22 acres approximately, is currently zoned "P" for
 public use. Both parcels were declared "excess" property in 2005 by resolution of the City Council and the
 Moreno Public Facilities Financing Corporation (the title holder of one of the parcels at the time).
- The City received an unsolicited offer letter from CV Communities which describes their desire to purchase the Nason Property for \$3,258,000 (based on the acreage) contingent upon the approval of a tentative map, change of zone to Residential, and various other conditions.
- It was agreed that the City should hire an independent real estate appraiser to determine the fair market value of the Nason Property zoned for residential development before taking the offer letter to the City Council in closed session for consideration.
- The goal is to complete the appraisal within 30 days. Prior to the completion of the appraisal, the City Attorney will review the Resolutions and other records associated with the property to make certain that the "excess" designation remains valid.
- John Strickler will contact Jerry Stephens and inform him of the proposed appraisal process.
- John Strickler will contact Kevin Donahue, MAI with Overland, Pacific, and Cutler to coordinate the appraisal based on residential zoning. However, future direction could include the preparation of an analysis of value based on different uses for the property.

I spoke to Jerry Stephens this afternoon and explained that we would be hiring an appraiser to determine the fair market value of the property. He said he understood and I promised to keep him informed of our progress. I also put in a call to Kevin Donahue and await a return call. I will let you know about the appraisal after I have spoken with Kevin.

Additionally, I will research the right-of-way remainder parcels we discussed after the meeting and get something back to you next week.

Good evening,

We are working a fatal traffic collision involving three vehicles on Moreno Beach and Bay Avenue. About 9:10 PM, an SUV, a Mercedes, and a motorcycle collided. The 24-year-old male motorcyclist from Moreno Valley sustained major injuries and was transported to RCRMC. A short time later, he succumbed to his injuries. The driver of the Mercedes had a complaint of pain and was also transported to the hospital. It is unknown at this time if any of the drivers was under the influence of alcohol or any other substance.

All lanes of Moreno Beach are closed between Alessandro and Cottonwood while the Traffic Accident Reconstruction Team conducts its investigation. Also, a 200 foot section of Bay Avenue is closed to traffic for the same purpose. The roadway will remain closed for the duration of the investigation. Traffic Recon officers are sensitive to the need to restore traffic flow and will do so as soon as possible. I will update you tomorrow if any new information becomes available.

Good evening,

The MVPD Special Enforcement Team served another search warrant today related to Section 8 housing assistance fraud. The residence in question is located in the 25700 block of Coriander, Moreno Valley. Investigation revealed that the primary resident, Julie Telles (49 years old) perjured herself on the Section 8 forms and fraudulently received over \$73,000 in Section 8 housing assistance. Officers also discovered that she was involved in the illegal sale of prescription medications. Telles was booked into RPDC on charges of perjury, Fraud, Defrauding a government entity, and drug sales. Two additional adult male suspects are being sought for various weapons related offenses.

This case is the fourth Section 8 fraud case investigated in recent weeks. In each case, HUD has canceled the fraudulently obtained government assistance and sought restitution, forcing the criminals living in our community to pack up and leave. An added benefit of these investigations is that once convicted, the offenders can never legally receive Section 8 assistance again.

The MVPD SET Team has been very successful addressing criminals in our community using this approach. As a result, we have established a team of two Detectives who will spearhead the effort to pursue all criminals who seek to defraud the system by illegally obtaining Section 8 housing assistance. I will keep you updated on our efforts.

Subject: Daytime Residential Burglary Arrests

Good evening,

This afternoon at 12:11 PM, officers responded to the 15600 block of Sage Court reference a residential burglary in progress. A witness saw several unknown suspects running from a residence and called 911. The witness followed the suspects as they fled the area in a vehicle. An MVPD officer in the area spotted the suspect vehicle traveling westbound on Brodiaea near Houston. As the officer got behind the suspect vehicle, it turned onto southbound Houston. The driver lost control of the vehicle and they collided into a fire hydrant, shearing it off. One suspect fled on foot but was arrested a short time later. The other three suspects remained at the scene and were taken into custody without incident. Moreno Valley Fire responded to shut off the hydrant and check the suspects for injuries from the collision. A search of the suspects and their vehicle revealed numerous valuable items believed to be stolen from the victim's residence. The items included jewelry, cameras, and laptop computers. An officer secured the residence after confirming it had been burglarized. The victim arrived a short time later and confirmed the property recovered belonged to her and that it had been stolen from her residence. The MVPD Gang Team responded to the scene and quickly identified all four suspects as members of the local Wild Flax Street Gang.

The suspects were identified as follows:

(Driver) Devonte Stevenson (18) of Moreno Valley Eric Hunter (20) of Moreno Valley Antonio Boatman (18) of Moreno Valley

The fourth suspect is a 16 year-old Black male juvenile who also resides in the City of Moreno Valley.

The three adult suspects were booked into RPDC on charges of first degree residential burglary and a gang enhancement. The juvenile suspect was booked into Juvenile Hall on the same charges. The MVPD SET Gang Unit will prepare the gang enhancement documentation on all four suspects.

Subject: Gang Intervention For Teens Operation

Good morning,

On February 20, 2013 the Region 5 Gang Task Force and the MVPD SET-Gangs Unit conducted a Gang Intervention for Teens (GIFT) program in the City of Moreno Valley. The operation targeted 12 specific individuals identified as being either recent initiates to the gang culture or kids affiliating with local gangs and in danger of becoming members of those gangs. These 12 young people are affiliated with up to 8 different criminal street gangs and are at a critical stage in their lives. The GIFT program, the brainchild of former Chief of Police Rick Hall, seeks to give these young people alternatives and educate parents about the signs of gang involvement.

Of the 12 youth selected for this effort, only 3 were not located. It appeared the addresses they listed were vacant or occupied by unrelated persons. Nine of the teens were present and officers met with them and their parent(s) to discuss the problem of gangs and gang affiliation. The sergeant in charge of the operation was pleasantly surprised to see that "more than half" of the contacts were very positive, with parents being receptive and showing concern.

Gang intervention at any level is a challenge. If we can get to a child before he or she falls too far into the abyss, there is a slim chance we can rescue them from the gang life. We will continue to try our best.

Talked to Kendra (VP of PR) with Ralphs. She confirmed what we had been speculating for months--that Ralphs (Kroger) will be closing the Ralphs store in Sunnymead Ranch. This location has been significantly underperforming since it opened and has been loosing over \$1 million annually. Slight uptick in sales with closing of Albertson's but not much towards becoming anywhere near profitable. Lease will expire in July 1. Owner of the center (family trust) had been discussing a rent reduction but not enough to make the store cash flow. Kroger (parent company of Ralphs) has made decision to not extend the lease and will close the store after close of business on Friday May 17. This decision by Kroger (Ralphs) is not subject to negotiation....Employees of the store will be informed of the closing tomorrow (Wednesday 3/13).

Kroger/Ralphs are pleased with the performance of their Food For Less stores in Moreno Valley, buy has no plans for any new Ralphs stores anywhere in the Inland Region.

Staff will continue to market the closed Albertson's-along with the soon to be vacant Ralphs store. Options include Stater Bros. (maybe another run at Albertson's location if acquisition price is decreased), new WalMart grocery store concept being rolled out in SoCal, Cardenas, Aldi (coming to CA in summer 2014) or independent grocery store concepts.

I would speculate that the news of Ralphs closing will hit the press on Wednesday or Thursday.

Good afternoon,

This morning about 9:15 AM, officers responded to the Comfort Inn at 23330 Sunnymead Blvd reference a trespassing and disturbance of the peace in the hotel office. On arrival, they contacted the manager who directed them to room #109. Officers obtained the identity of the guests and ran them through law enforcement computer systems to determine who they would be dealing with. That inquiry revealed that the male subject, Nathanial Harms (35) was wanted on felony drug warrant. The search warrant was granted in reference to multiple forms of suspected fraud, including welfare fraud and Section 8 fraud. The primary suspect, Bettina Ross (37) has been drawing various forms of government assistance since 2001. During that same time frame, she has worked and earned unreported income. Also, she has allowed suspect #2, Damon Ross (38) to live at the residence throughout that time, in violation of her Section 8 agreement. Suspect #2 is a career criminal, convicted felon, and was currently wanted on a \$1 million felony arrest warrant for child endangerment and theft.

During service of the warrant, officers found and arrested Damon Ross on his warrant. They also located several grams of methamphetamine and items indicating the suspects were involved in the sale of that illegal drug. Finally, officers encountered 3 children, ranging from 3 to 14 years old. The Sheriff's Drug Endangered Children Unit and Riverside County Child Protective Services responded to the residence and took the kids into protective custody. It appears that Bettina Ross has fraudulently obtained more than \$175,000 in state or county financial aid during the past 12 years. She confessed to multiple felonies, including fraud, defrauding a government entity, perjury, drug charges, and child endangerment and was booked into RPDC. Damon Ross was also booked on his warrant, drug charges, and child endangerment charges.

In addition to criminal charges, we will pursue restitution for the fraudulently obtained taxpayer dollars. HUD will revoke services permanently. All other involved governmental assistance agencies will be notified of the fraudulent activity.

Subject: Shooting near Home Depot with road closure

Good evening,

Today about 2:55 PM, officers responded to the Home Depot store on Pigeon Pass just north of SR 60 reference a shooting and traffic collision. On arrival officers learned that a Chevy truck occupied by two adult males was exiting the northernmost exit of the Home Depot parking lot when an unknown male suspect walked up behind their vehicle and began shooting at them with a handgun. The victims sped away southbound Pigeon Pass, but quickly collided with a southbound Chevy Suburban. The victim in the passenger seat fled the crashed truck on foot because he feared the suspect would continue shooting. The passenger was located a short distance away and was found to have a non-life-threatening gunshot wound to his upper back.

The driver of the victim vehicle sustained minor injuries during the crash. Both victims were transported to RCRMC for treatment. The driver of the Suburban was not injured. Northbound Pigeon Pass was closed for about two hours while the incident was investigated. An extensive search was conducted for the suspect by both ground units and the Sheriff's helicopter. The suspect was not located. Video footage is being sought from all surrounding businesses.

The suspect was described as a White male adult, 20-30 years old with tattoos on both arms. He was last seen wearing a black shirt and black pants. The motive for this shooting is unknown at this time. The investigation is continuing.

When one of the reporting parties called about this incident, he informed Dispatch that Congressman Mark Takano was inside the Home Depot speaking with a group of Home Depot employees at the time of incident. 

Preservation of Evidence Demand

Dear Ms. Halstead:

The Riverside County District Attorney's Office has learned that the Moreno Valley City Council will consider adopting Resolution No. 2013-82, a "Resolution Adopting Updated Records Retention Schedules and Authorizing Destruction of Certain City Records" at its regular meeting on October 22, 2013.

The District Attorney's Office has reason to believe that litigation may result from matters currently under investigation with regard to the City of Moreno Valley and that relevant evidence potentially may be destroyed if Resolution No. 2013-82 is passed and implemented. This information may be in the City of Moreno Valley's possession or control and the City has a duty to preserve that information.

Therefore, the District Attorney's Office demands that the City of Moreno Valley immediately take action to protect and preserve until further notice any of that information that is in its possession or under its control until further notice.

Specifically, the District Attorney's Office demands that the City of Moreno Valley immediately suspend deletion, overwriting and/or any other destruction of records and electronic stored information (hereinafter "ESI") connected, either directly or indirectly, to the following:

- All records and ESI associated with or concerning Highland Fairview, Iddo Benzeevi, Jerry Stephens, Tom Owings, Marcelo Co, Jesse Molina, Victoria Baca, Richard Stewart, Yxstian Gutierrez and Michael Geller.
- All records and ESI associated with or concerning all City of Moreno Valley elected and appointed public officials and Department Heads.

- All records and ESI associated with or concerning pending or approved development construction projects, infrastructure and/or new infrastructure projects located in the City of Moreno Valley.
- All records and ESI associated with or concerning communications to and from City of Moreno Valley employees, elected and/or appointed public officials regarding the hiring, employment and discharge of former City Manager Henry Garcia.
- All records and ESI associated with or concerning the following development projects: Skechers, World Logistic Center, Prologis, Aquabella Development, Ridge Property Development and Nason Street infrastructure improvements.

The District Attorney's Office is specifically demanding that you preserve all documents, tangible things and ESI potentially associated with or concerning the matters identified above for the time frame of January 1, 2008 to present.

ESI, as used in this demand, should be afforded the broadest possible definition and includes (by way of example and not as an exclusive list) any and all information electronically, magnetically or optically stored as:

- Digital communications (e.g., e-mail, voice mail, instant messaging);
- Word processed documents (e.g., Word or WordPerfect documents and drafts);
- Spreadsheets and tables (e.g., Excel or Lotus 123 worksheets);
- Accounting Application Data (e.g., QuickBooks, Money, Peachtree data files);
- Image and Facsimile Files (e.g., .PDF, .TIFF, .JPG, .GIF images);
- Sound Recordings (e.g., .WAV and .MP3 files);
- Video and Animation (e.g., .AVI and .MOV files);
- Databases (e.g., Access, Oracle, SQL Server data, SAP);
- Contact and Relationship Management Data (e.g., Outlook, ACT!);
- Calendar and Diary Application Data (e.g., Outlook PST, Yahoo, blog tools);
- Online Access Data (e.g., Temporary Internet Files, History, Cookies);
- Presentations (e.g., PowerPoint, Corel Presentations)
- Network Access and Server Activity Logs;
- Project Management Application Data;
- Computer Aided Design/Drawing Files; and,
- Back Up and Archival Files (e.g., Zip, .GHO)

All ESI must be preserved so that it can be retrieved at a later time. The information must be preserved in its original electronic form so that all information contained within it,

City staff: I want to continue updating you on what little I do know about the investigation that began last May with the search warrants served at the residences of our Council Members (the ones in office at that time) and others. Subpoenas were delivered to the Clerk's Office today for documents related to the items listed below (most of which, the Clerk indicates, have already been provided to them). In addition, I was served with a subpoena to appear before a grand jury next Wednesday, as was Tom DeSantis. Our testimony is being requested just as witnesses.

Also, some in the media have tried to make an issue of an item on tonight's Council agenda; it is a routine update by the City Clerk of the City's record retention policy. This is done every few years to keep current with technological advancements and to comply with State law. Other cities do this as a routine update as well. Prior year updates were approved by the Council in 2003 and again in 2007. An outside consultant has been working on this update for over one year, obviously well before any investigation began. Tonight's item is on the consent calendar, as was the previous update. The City Clerk will be pulling this item from the agenda and preparing a comprehensive report to present to the City Council at a later date when the consultant can attend and provide information regarding this routine update. I don't know if the record retention update prompted today's influx of subpoenas, but as always the Clerk's Office and City staff will comply fully in providing copies of these items.
